From July 2020 to June 2021, the Organization provided \$322,571,005 in grants and material aid to global ministry partners serving the poor and vulnerable. This aid included \$1,325,284 in COVID-19 prevention supplies to seven countries; \$17,145,443 in disaster relief supplies shipped to survivors of a volcanic eruption and six hurricanes; 20,592,416 Vitafood meals sent to the hungry; 391 safe, sturdy homes built or repaired; clean, safe water provided for 96,417 people; \$176,785 in microloans sent to 176 families; technical training provided to 7,078 farmers to improve their crop yields; and religious community support provided to 4,925 people. Because the Organization distributes these grants and resources through local Catholic parishes and ministries, these efforts also have a major spiritual impact on

(Revenue \$) From July 2020 to June 2021, the Organization supported 318 projects meeting the needs of the world's poor and vulnerable. These projects were managed by a team of project officers in partnership with local dioceses, parishes, missions, and other groups dedicated to works of mercy. The reach of this effort was enormous, from Central and South America and the Caribbean to Africa and East Asia. Among the Organization's many partners, a select few are chosen to be Community Transformation (CT) partners. CT partner ministries works closely with the Organization to implement a strategy of long-term change that encompasses multiple areas of need in targeted communities and gives attention to the material and spiritual well-being of the poor.

4c (Code:) (Expenses \$ 4,347,250. including grants of \$) (Revenue \$) The Organization raises awareness of the Church's global poverty relief and development work by sending Outreach Priests to U.S. parishes and providing Catholic communities with service opportunities and liturgically themed fundraising programs. From July 2020 to June 2021, the Organization's Priests were hosted in parishes throughout the U.S. 658 times. Many parishes also learn about global missions through the Box of Joy program, which gives Catholics the opportunity to send Christmas gifts to children who might otherwise receive nothing at all. This linking of U.S. Catholics and parishes with their counterparts in developing countries is an important spiritual goal of the Organization because the interaction builds community within the Catholic Church and helps American Catholics benefit from the richness of faith found in

The Board of Directors performs periodic evaluations of the Chief Executive Officer's compensation to evaluate the appropriateness of his compensation as compared to other Chief Executive Officers operating within religious, non-profit, relief and development organizations. Past compensation reviews have determined the Chief Executive Officer of the Organization has been compensated far less than his counterparts in other "like" organizations. Compensation information related to other Chief Executive Officers of comparable organizations was compiled from publicly available Federal Forms 990 and presented by the Chief Financial Officer of the Organization to the Board of Directors for their review in February of 2021. The Board of Directors approved a four-year process of raises effective April 1st of 2021, 2022, 2023, and 2024 for the Organization's Chief Executive Officer to be closer aligned with Chief Executives within comparable organizations. All other officers and key employees of the Organization receive raises based on the consumer price index (inflation) plus up to roughly 4% variable based on performance like all other employees within the Organization.
