

1 Briefly describe the organization's mission: The Organization mobilizes the global Catholic Church to transform the poor and their communities materially and spiritually for the glory of Jesus Christ.

4a (Code:) (Expenses \$ 328,766,762. including grants of \$ 322,591,922.) (Revenue \$ 95,105.) From July 2021 to June 2022, the Organization provided \$14,177,004 in grants and material aid to global ministry partners serving the poor and vulnerable. This aid included nearly 26 million Vitafood meals sent, 282 homes constructed, clean water provided to 361,512 people, and more than \$2.3 million in disaster relief supplies shipped. Among the disasters that the Organization responded to was the COVID-19 pandemic, as the Organization's partners continued to request help to deal with the economic impact and ongoing health protocols. The Organization also sent more than \$2 million in relief supplies to southern Haiti in the aftermath of the August 2021 earthquake. Because the Organization distributes these grants and resources through local Catholic parishes and ministries, these efforts also have a major

From July 2021 to June 2022, the Organization supported 187 projects meeting the needs of the world's poor and vulnerable. These projects were managed by a team of project officers in partnership with local dioceses, parishes, missions, and other groups dedicated to works of mercy. The reach of this effort was enormous, from Central and South America and the Caribbean to Africa and East Asia. Among the Organization's many partners, a select few are chosen to be Community Transformation (CT) partners. CT partner ministries works closely with the Organization to implement a strategy of long-term change that encompasses multiple areas of need in targeted communities and gives attention to the material and spiritual well-being of the poor.

4c (Code:) (Expenses \$ 5,552,359. including grants of \$ 0.) (Revenue \$ 0.) The Organization raises awareness of the Church's global poverty relief and development work by sending Outreach Priests to U.S. parishes and providing Catholic communities with service opportunities and liturgically themed fundraising programs. From July 2021 to June 2022, the Organization's Priests were hosted in parishes throughout the U.S. 1,068 times. Many parishes also learn about global missions through the Box of Joy program, which gives Catholics the opportunity to send Christmas gifts to children who might otherwise receive nothing at all. This linking of U.S. Catholics and parishes with their counterparts in developing countries is an important spiritual goal of the Organization because the interaction builds community within the Catholic Church and helps American Catholics benefit from the richness of faith found in

Language was also added to the bylaws outlining the compensation setting policy for the CEO and detailing the authority and duties of the officers identified in the bylaws. The bylaws were also amended to include an article detailing indemnification of officers and directors.

In addition, the Organization's articles of incorporation were restated during the fiscal year ended June 30, 2021. Amendments to the articles included updates to the Organization's purpose. Moreover, language was

added distinguishing the board's authority to designate recipient organizations upon the Organization's dissolution. In addition, references to three distinct classes of directors and 3-year terms were removed and the Organization's article of indemnification was removed.

Past compensation reviews have determined the Chief Executive Officer of the Organization has been compensated far less than his counterparts in other "like" organizations. Compensation information related to other Chief Executive Officers of comparable organizations was compiled from publicly available Federal Forms 990 and presented by the Chief Financial Officer of the Organization to the Board of Directors for their review in February of 2021. The Board of Directors approved a four-year process of raises effective April 1st of 2021, 2022, 2023, and 2024 for the Organization's Chief Executive Officer to be closer aligned with Chief Executives within comparable organizations. All other officers and key employees of the Organization receive raises based on the consumer price index (inflation) plus up to roughly 4% variable based on performance like all other employees within the Organization.
